

TERMS AND CONDITIONS OF FINANCIAL AID

DISCOUNT

Type of discount:

- I. Early Settlement Discount (10%)
- II. Senior Citizenship Discount
- III. Loyalty Discount
- IV. Physical Disadvantage Discount
- V. Institutional Discount

I. EARLY SETTLEMENT DISCOUNT / FULL SETTLEMENT (10%)

- 1) Incentive of 10% deduction from the Annual Tuition Fee will be given for student who makes full payment for 3 semesters (eg : JAN, MAY, SEPT) by end of the 3rd week after new semester starts commencing.
- 2) Applicable for MALAYSIAN student ONLY.
- 3) Not applicable for PHD student.
- 4) The incentive is only available to student who have no outstanding balance from the previous semester.
- 5) The discount will be deducted by semester/ modular/ yearly basis depending on the programme mode.

II. SENIOR CITIZENSHIP DISCOUNT (50 %)

- 1) Eligible to senior citizen who is 55 years old and above upon registration.
- 2) **50%** discount on **TOTAL TUITION FEE / RESEARCH FEE** only.
- 3) The qualifications are based on the year of birth in IC by checking at *myAeu* Portal - Student Profile.

- 4) Applicable to **ALL ACADEMIC PROGRAMMES** and to **MALAYSIANS** only.
- 5) Other incentives and discount will not be applicable.
- 6) The discount will be deducted by semester/ modular/ yearly basis depending on the programme mode.

III. LOYALTY DISCOUNT (10 %)

- 1) Discount of 10% on **TUITION FEE / RESEARCH FEE** will be given to student who enroll for a new academic programme upon completion previous academic programme in AeU.
- 2) Other incentives and discount will not be applicable.
- 3) The discount will be deducted by semester/ modular/ yearly basis depending on the programme mode.

IV. PHYSICAL DISADVANTAGE DISCOUNT

- 1) Eligible to student who is physically disadvantages and registered with Social Welfare Department of Malaysia.
- 2) 75% discount on total **TUITION FEE** will be given to eligible student.
- 3) Other incentives and discount will not be applicable.
- 4) The discount will be deducted by semester/ modular/ yearly basis depending on the programme mode.

V. INSTITUTIONAL DISCOUNT

- 1) Criteria for Institutional Discount :
 - I. Institution must sign MOU with Asia e University (AeU).
 - II. 15% discount on total **TUITION FEE**.

- III. Fees can be paid either by student or the institution.
- IV. Other incentives and discount will not be applicable.
- V. The discount will be deducted by semester/ modular/ yearly basis depending on the programme mode.
